Intellectual Property Rights

This document outlines the intellectual property rights and usage terms for all Neglected Labs NFT collections.

Introduction

Neglected Labs provides clearly defined IP rights for holders of the Neglected Ghosts and The One's Legacy (T1L) NFT collections. This document explains the rights, restrictions, and ownership structure for each collection.

Neglected Ghosts - Limited IP Rights

Neglected Ghosts are designed to remain kid-friendly and suitable for family environments.

Rights Granted:

- Personal Use: You may print, display, or modify your NFT for non-commercial purposes.
- Limited Commercial Use: You may create and sell products as long as all content remains kid-friendly.
- Digital and Physical Display: You may display your NFT on personal websites, galleries, or events.

Restrictions:

Neglected Ghosts may not be used in any of the following contexts:

- Alcohol, drugs, vaping, or substance-related content
- Pornographic or adult material
- Profanity, hate speech, or offensive language
- Depictions of violence or harmful behaviour
- Political or religious promotion

Neglected Labs may restrict or revoke usage if these terms are violated.

The One's Legacy Collection - Full Commercial Rights

The One's Legacy Collection grants full commercial rights to NFT holders.

Rights Granted:

- Full Commercial Use: You may create products, brands, or business ventures using your NFT.
- Media Usage: You may feature your NFT in films, games, comics, animations, or other creative works.
- Marketing and Advertising: You may use your NFT in commercial campaigns and promotional materials.
- Licensing: You may license your NFT to businesses, partners, or third parties.

Restrictions:

- None. Holders may use their NFT in any content category, including mature, political, or commercial material.

Commercial rights fully transfer to the new owner upon resale.

Intellectual Property Ownership

Purchasing an NFT gives you ownership of the token itself. Copyright ownership of the artwork does not transfer unless explicitly stated.

- Neglected Labs retains copyright for all Neglected Ghosts artwork.
- The One's Legacy holders receive unrestricted usage rights, but not the underlying copyright.
- Copyright is transferred only when formally stated.

These rules protect long-term brand direction and project integrity.

Enforcement and Violations

Neglected Ghosts: Misuse of artwork in restricted categories may result in takedown action or legal enforcement.

The One's Legacy: Because T1L provides full commercial freedom, Neglected Labs does not intervene in usage disputes.
